Why advocate on a county level?

Counties and municipalities can create their own set of safety guidelines to counter the spread of COVID-19. Lifting our voices locally, while continuing to contact our state legislators, can be a powerful way to advocate.

When the pandemic began, Governor Evers issued a safer-at-home Executive Order, following the Wisconsin Department of Health Services (DHS) recommendations. After the Wisconsin Supreme Court struck down most of that order, some counties put their own rules into place.

We are already a COVID epicenter. If the courts or legislature stop current or future statewide protective mandates that are based on science, our state's already large number of COVID cases could grow exponentially. Without the Wisconsin State Legislature offering a healthy plan, counties and cities will shoulder the burden of protecting their communities. *If attempts to challenge statewide mandates are successful, will your county be ready?*

What can I do to help?

Please pray and take action as you learn about where your county stands. You can search your county website (see link at the top of this page) or call or email your county officials. Ask if they have rules that follow DHS recommendations or a specific rule you are concerned about in place. Don't be shy about being in touch more than once as circumstances change.

If your county has rules based on DHS recommendations, please thank your county officials and offer your continued support for their leadership in protecting your community. Note that many officials received hate mail simply for issuing a mask mandate before a statewide mandate was ordered. This is all the more reason for offering support for solid leadership!

If there are no current rules protecting the spread of COVID in your county, please advocate for your local leaders to create rules following DHS recommendations.

Who are my County Officials?

Counties either have a County Supervisor or a County Manager. There are also County Board Supervisors. Some counties may say that decisions about how to protect people from COVID are left to county health departments. If that is the case, after still voicing your concern to your county official/s, ask how to contact the correct health officer to repeat your message.

Email Template for County Officials
