## Take Action on Immigration, Creation Care, and Homelessness.

IMMEDIATE ATTENTION NEEDED: <u>Ask your lawmakers to co-sponsor</u> three bills supporting DACA Recipients in Wisconsin!

LOPPW is asking for Wisconsin residents to contact their lawmakers on LRB-1527/1, LRB-1528/1, and LRB-1627/1 for co-sponsorship. **The** 

deadline for co-sponsorship is 12 p.m. on Friday, December 8th, 2023. These three bills were all announced this week on pivotal issues surrounding those in the deferred action for childhood arrivals program (DACA). There are 578,680 DACA workers in the United States in total and 5,790 right here in Wisconsin.

LRB 1527/1 would allow DACA recipients to pay in-state tuition for Wisconsin schools like most residents who have lived in the state for 12 months.

LRB-1528/1 would create a tax credit for DACA recipients of \$250 for their annual taxes. Currently, DACA recipients have to go through many hurdles to remain in Wisconsin due to their status.

Lastly, LRB-1627/1 would allow individuals part of the DACA program to be eligible to receive occupational licenses.

## **Support Farmers and the Environment via the Transition to Grass Pilot Program**

SB 619/AB 655 initiates a pilot "transition to grass pilot program" in the Dept. of Agriculture, Trade and Consumer Protection. Providing support and grants to farmers who are implementing livestock grass-based managed grazing systems and farmers and agribusinesses in the grass-fed livestock business is a win-win. The practice where

livestock are systematically rotated through pastureland optimizes their nutrition and the land's health. Learn more within the body of the <u>action alert.</u>



Increase support for people experiencing poverty and homelessness! Senate Bill 557 is a comprehensive bill that would address issues relating to housing, homelessness, and poverty. It would help support the transition of people experiencing homelessness into more independent living, establish an emergency rental assistance program, and expand grant housing support. It would better fund services as well as track their success through reporting. There would be a Housing Choice Voucher Program that

would be piloted for children. There would be support for services such as Internet services, civil legal services, and workforce development. There would also be funding to help those exposed to lead, transportation, and to assist the Institute for Research on Poverty at UW-Madison study and provide

an annual report to the public on poverty in Wisconsin. <u>Increase support for people experiencing</u> poverty and homelessness!
